Piyali Basak makes history climbing Everest without supplementary oxygen



KOLKATA: Mountaineer Piyali Basak on Sunday achieved a new milestone in the history of Mountaineering in West Bengal by climbing Mount Everest (8848 mts) without the help of supplementary oxygen, a report reaching said. Basak, who successfully scaled Mount Dhaulagiri I (8167 m) on October 1, 2021, and became the first Indian woman on the summit of world's seventh highest mountain without supplementary oxygen, unfurled the national tri-colour (Indian flag), the report added quoting her agent office M/S Pioneer in Kathmandu.

"Piyali Basak has reached the top of the world without supplemental oxygen support," the message said.

Piyali Basak, who was out to summit Mount Everest and Mount Lhotse without the supplementary oxygen support, almost had to give up her expedition owing to funds shortage but she finally received the permission for Everest on Friday morning.

In her late 20s, Piyali Basak made her summit push around 7 PM (Nepalese time) on Saturday and reached the summit around 0900 (Nepalese time) hours along with a sherpa guide from Nepal side.

MUMBAI: A dispirited Delhi Capitals Captain Rishabh Pant on Saturday said he felt Mumbai Indians' Tim David had nicked the ball, but his teammates standing in the circle thought otherwise, and hence he did not refer it to the TV umpire. "I thought there was something (about not reviewing the Tim David caught behind). Everyone standing in the circle wasn't convinced and at the end I didn't go up," he said at the post-match presentation ceremony at Wankhede Stadium.

Pant had not asked for a review after the replay showed David had nicked the ball behind. This mistake however cost DC heavily as David knocked them out of IPL with his 40-odd hurricane knock. Pant said DC were 5-7 runs short, but they bowled really well, the dew played spoil sports towards the end. "We bowled well throughout the tournament, but dew came in towards the end and we didn't bowl to our plans. It's hard but we got to take it on our chin and learn from it."
